Memory boxes can either hold items brought in my residents/family such as decorative pieces or pictures. If residents/family choose not to fill the memory box, recreation will create a personalized sheet including the residents name and items they enjoy for this box.

Question: Residents very happy about recreation facilitator re-joining us on MP3. Residents are looking forward to having more activities present on the unit. Residents are wondering what the protocol is for when a recreation facilitator has called in sick to work, residents feel there should be back up staff on site to facilitate these activities rather than having them cancelled.

Response: Recreation explained to residents that at this time we have 1 recreation facilitator assigned to each floor, in the event someone calls in sick the other recreation facilitators will do their best to have an activity on the unit, but this all depends on their time and activities planned on their corresponding units.
