## TRANSITIONAL CARE: VISITATION UPDATE June 25, 2021

With updated public health guidelines, MHC is able to welcome fully vaccinated\* general visitors to our TCUs provided we do not have any COVID-19 cases.

\*You are considered "fully vaccinated" two weeks after your second COVID-19 immunization.

Visitors continue to be defined by whether they are partners in client care versus those who are visiting for more social reasons.

Essential Care Partners: a person the client identifies as their caregiver and are approved by our resident care managers.

General Visitors: family and friends who visit for social reasons. Canadian out-of-province visitors are considered to be general visitors.

# FULLY VACCINATED VISITORS

- One visitor per client is welcome on units, providing they have been fully vaccinated and the client they are visiting has been vaccinated
- Private rooms: visitors are welcome to visit with clients in their rooms
- Shared rooms: designated visiting spaces are available on each unit

Visits outside of the units are unavailable at this time.

## UNVACCINATED ESSENTIAL CARE PARTNERS

Essential Care Partners who are not vaccinated are required to phone the unit and speak to the resident care manager to discuss visitation.

### **UNVACCINATED GENERAL VISITORS**

We understand not everyone can be vaccinated for a variety of reasons, however guidelines do not yet allow general visitors who have not been immunized.

#### **General Visiting Hours**

Visiting hours are 10 a.m. - 12 p.m. and 1-4 p.m. daily.

### **Booking visits**

It's important visitors – both essential care partners and general visitors – book in advance in order for us to ensure capacity and physical distancing requirements.

At this time, general visits will be limited to an hour. No more than one visit a day is recommended to prevent coming on and off the unit multiple times.

#### **Demonstrating proof of vaccination**

Photo ID will be required along with proof of vaccination for visitors over the age of 19.

We recommend you have a secure immunization card mailed to you, rather than having to login to the portal on a device to show your QR code every time you visit.
