Visitation update: new space

We are very happy to have been granted provincial funding to renovate an existing indoor space for visits at Misericordia Place. As the guidelines evolve, this space will afford us options for visitation going into this second wave of the pandemic and the Influenza season.

We will be renovating the suite which is directly connected to the Misericordia Place courtyard. This space holds a special spot in our hearts as it's affectionately known as "the Nun's Suite" because the last two Misericordia Sisters who lived in Winnipeg resided in this suite.

As per provincial requirements, this space will allow visitors to enter the facility directly from outside. Air quality mechanisms will also be installed. We are blessed to have this functional space that we'll be able to develop. We are waiting to hear when renovations will start and will share details as we have them.



This indoor visiting space means Misericordia Place will not require an external "pod" you may have been reading about in the news.

COVID-19 precautions and communication

We have received some questions about what would happen if a residents or staff member tested positive for COVID-19. Although we have hope that this will not happen, as a team we have been planning for this possibility since the onset of the pandemic in March.

In the event of a positive case of COVID-19, all families on the involved floor will be contacted. The immediate action would be to isolate any affected residents and to send any involved staff home. Provincial guidelines will be enacted in terms of suspension of visits and activities. Our plan has been designed to be flexible, depending on the specific situation.

Resident-care teams will keep you informed of any changing symptoms your loved one may have. As the situation unfolds, we will be doing our best to provide up to date information.
